The State Government has decided that -2.

- The millers who are willing to store paddy above 5000 MT and also give Bank Guarantee for the amount over and above 5000 MT as per the provisions of Clause 5 (c) (xv) of the ibid policy, on production of proof that they have applied for the same with a bank, may be considered for allotment, subject to fulfillment of all other conditions of the ibid policy.
- b. Paddy to the limit of 5000 MT may be stored but not beyond the limit until and unless requisite Bank Guarantee is produced/deposited with the State Procurement Agencies.
- If any amount is stored over and above 5000 MT without the deposition of Bank Guarantee, the District Manager of the State Procurement Agency concerned shall be held personally responsible and also, the quantum of paddy stored over and above 5000 MT, without Bank Guarantee, shall be shifted at the risk and cost of the miller.
