- Any miller who is a defaulter for non-delivery/non-payment of levy rice /penalty for the years 2007-08, 2008-09 or 2009-10 or 2010-11 will be liable to give cheques (with one month validity) of the like amount for allotment of paddy during KMS 2013-14. In case of non-payment by the miller or non-refund by FCI within one month, cheques will be replaced by bank guarantees.
- The mills with a capacity of upto 2 MT are allowed to convert a maximum of 7 (seven) wagons of rice without getting any bank guarantee/FDR and mills with a capacity of more than 2 MTs are allowed to convert a maximum of 14 wagons of rice without any bank guarantee/FDR.
